## IMPATIENCE WITH IMPATIENS

Did you lose your Impatiens flowers in your garden this year? Varner's Garden Center and Ginger Valley have confirmed that we are experiencing a die out of Impatiens flowers only. A disease called "downy mildew" is affecting the impatiens plants in our area. The fungus has been moving North and finally reached Michiana. It is advised not to plant Impatiens for the next 2-years, to allow for the fungus to die out naturally. It is recommended that other shade tolerant species be planted instead.

## GUMWOOD ROAD CONSTRUCTION

The utility work has already begun along Gumwood Road. Phase I will begin in the Spring of 2014 and include a Roundabout at Brick intersection. Phase II will follow with the installation of a roundabout at Adams road intersection and road resurfacing up to Michigan border, to be complete by the Summer of 2015.
